As a special offer in conjunction with the ClarionLive! DevCon, DMC is considering offering to convert your application to SQL for \$199. Please take the survey if you are interested. The conversion offer (TPS application - C6 and/or C7 - to SQL) is done in two steps. First, DMC reads through your application's DCTX file and fixes common problems like missing primary keys, Date/Time problems, variable names the use SQL reserved words, missing GUIDs. Next, DMC parses through your TXA file and creates a new SQL version of your application. The result - you can have a working SQL version of your TPS App in minutes. You can merge your TPS and SQL versions into one dual application so you don't have to deploy different versions. DMC allows you to add instructions to your TPS code to direct DMC to turn on or off sections of your code in the conversion process - that way you only have to maintain one TPS application. When you upgrade that application you can quickly re-convert it to SQL and merge them all together into one switch-hitting application.

Installing And Configuring MySQL 5

Although a lot of Clarion applications still use TPS files (hey, some even use Clarion DAT files), more and more I see Clarion developers moving to SQL. Clarion Magazine has published a number of MySQL-related articles, but it's a while since there's been an article on the basics.

In this article I'll show how to install MySQL and MyODBC and create a simple wizarded application for a MySQL database. But first, a word about licensing.

Do I need to pay an annual MySQL license fee?

While MySQL is an open source database, it isn't always a free database.

Here's the core issue: if you *distribute an application* (as source or as compiled code) and *that app uses MySQL*, then you either need a commercial license *or* you need to release your application's source under the open source GNU General Public License (GPL).

I don't know too many Clarion developers who are comfortable releasing their source code. And if you use third party products you're probably prevented from doing that anyway. Heck, it's probably not possible to release a third-party free Clarion app under the GPL anyway because you're shipping closed source Clarion DLLs as well, and those DLLs would have to be GPL'd. Good luck with that.

The common free use of MySQL is as backing for web sites, which works because traditionally web sites haven't been actual applications. But depending on how you read the license, if your web site makes use of Javascript (or any other code) then perhaps you're not eligible to use MySQL for free without releasing your Javascript and all the server code under the GPL.

In other words, the safe assumption is you need a license. The minimum cost (as of this writing) is [\\$599 per server per year](#). That's cheaper than shelling out in excess of \$7000 *per processor* for Microsoft SQL Server, but note that MySQL's prices are listed as *per year*. That's the minimum subscription price which gets you updates for one year and up to two support incidents - you can pay as much as \$4999 per year for the Platinum edition.

But do you really need to pay an annual license fee? According Matthew Montgomery, Senior Support Engineer, "Usage of the MySQL Enterprise edition does require a support contract to be purchased with it."

That seems pretty clear.

Okay, now that the major pain point has been covered, it's on to installing and using MySQL.

Installing MySQL 5.1

As of this writing the current release of MySQL is 5.1.51. You can download it [here](#).




Figure 1. Starting the installer

On running the installer you'll see the window in Figure 1.

For most situations the typical setup is fine, but I'm in the habit of using the Custom setup (as in Figure 3) whenever I'm given the opportunity, if for no other reason than to see what is being installed and where. But in this case I had another reason for doing the custom setup - I already had an older version of MySQL installed, and I wanted to make sure I didn't have any conflicts between the two versions.




Figure 2. Setup type




Figure 3. Choosing the advanced setup

The default program features include all the things 99.9% of MySQL users will need: The server itself, the command line shell, the utilities and a configuration utility. The only way you'd need the C include files is if you found it necessary to write your own interface to MySQL.




Figure 4. Setup options




Figure 5. Ready to install




Figure 6. Installing

As installation completes you'll see some advertising for MySQL Enterprise, which is what you've just installed. The MySQL folks don't hit you over the head with your need to buy a license for non-GPL, non-web use. Really they don't tell you that at all during the installation process. They just hint, via the ads, that you may need a subscription. It's an interesting business model, as there are surely many MySQL installations out there that legally need a commercial license and don't have one.

Keep it legal. If your use of MySQL requires a license, buy that license.




Figure 7. Subscription advertising




Figure 8. More advertising

Once the MySQL is installed, the installer runs the setup Wizard.




Figure 10. The Configuration Wizard

Since I already have MySQL installed on this computer I'm going to go ahead and use the Detailed Configuration option.




Figure 11. Choosing the detailed configuration

I've chosen the Developer Machine option because I'm really only using MySQL for minimal testing. If I needed to push some heavier data through MySQL during testing I'd probably go for the Server Machine option as that would give MySQL a little more access to memory. And clearly you only want to use the dedicated machine option when MySQL is the only server application running.




Figure 12. Instance configuration

MySQL takes an engine-based approach to data storage. There are a variety of storage engines available, but in general the two options are MyISAM (non-transactional) and InnoDB (transactional). For business application use you probably want to choose the Transactional Database option, but in light service I expect Multifunctional Database will do fine. In either case you should use the InnoDB storage engine to improve database integrity.




Figure 13. Choosing the database type




Figure 14. Setting the datafile directory

A long time ago I always dedicated my C drive to Windows only, and never data. After a brief flirtation with keeping everything on one big partition I'm back to separate data drives. In Figure 14 I'm using a directory on my D drive for my databases.

Again since this a development install of MySQL I'm not worried about a high number of connections, so the default setting is fine.




Figure 15. Setting connection numbers

I normally access MySQL via TCP/IP, so the default networking setting is what I want.




Figure 16. Enabling networking and strict mode.

In Figure 16 I've shown the port as 3306, which is the default. In fact I changed that to 3307, since I already have an older version of MySQL running on port 3306.

Strict Mode ensures that only valid data can be entered into the database. [From the documentation:](#)

Strict mode controls how MySQL handles input values that are invalid or missing. A value can be invalid for several reasons. For example, it might have the wrong data type for the column, or it might be out of range. A value is missing when a new row to be inserted does not contain a value for a non-NULL column that has no explicit DEFAULT clause in its definition. (For a NULL column, NULL is inserted if the value is missing.)

The default character set is Latin1, but in the interests of forward compatibility I've selected UTF8. For more on UTF8 and Unicode see [Phil Carroll's excellent article](#) on the subject.




Figure 17. Choosing the character set

When MySQL is installed as a service it launches automatically whenever you boot Windows, and runs without user intervention. If you don't install MySQL as a service you'll have to start it manually. While that might be acceptable for a development machine, it's generally not an option for a production database server.

You will probably also want to include the Bin directory in the Windows PATH environment variable. That way you'll be able to run the various command line utilities without having to first locate and navigate to the MySQL Bin folder.




Figure 19. Adding the Bin directory to the PATH

The root password gives you full access to the MySQL server. You really should only use the root login for administrative purposes - any individuals or applications using the database (s) should have their own logins.

The Configuration Wizard is now ready to run.




Figure 21. Ready to configure




Figure 22. Configuring MySQL

After MySQL is installed and configured, it's ready for use. Run the MySQL Command Line Client from the Windows menu. You'll be asked for the root password you supplied during the MySQL installation.

Once you're logged in you're ready to use the client to do administration tasks such as creating databases.




Figure 24. Ready to import the database

Installing the sample database

I Googled around for a sample database and [found one at MySQLTutorial.org](#). Download the zip and extract the SQL file to a temporary directory. I used D:\temp.

Next, from the command line client type the following, substituting your temp directory as needed:

```
mysql > \. d:\temp\sampl edatabase. sql
```

The \. tells the command line client to process the following text file as input.

To verify the import has worked, use this command to switch to the newly-created database:

```
mysql > USE cl assi cmodel s;
```

Use `show tables` to display the table names:

You're almost done. Earlier I advised against using the root login for routine data access, so you'll need to set up a user with rights to use the ClassicModels database:

```
mysql > create user 'clari onmag' @'l ocal host' i denti fi ed by 'devroadmaps' ;
mysql > grant all pri vi leges on cl assi cmodel s. * to 'clari onmag' @'l ocal host' ;
```

The first statement creates the user named `clari onmag` with the password `devroadmaps`. The second statement gives that user full rights to the ClassicModels database (you probably wouldn't want to give a real user full rights, since that includes creating, modifying and deleting tables, but this is a test setup so no major worries).

In [Part 2](#) I'll show how to install MyODBC and I'll wizard up an application to work with the MySQL database.

Creating a MySQL 5 Clarion Application

In [Part 1](#) I showed how to install MySQL5 and create a sample database. In this concluding article I'll walk through installing the MyODBC driver and I'll wizard up an application to use the sample MySQL database.

Installing MyODBC

When you install MySQL that's all you install - just the database server. You still need a way to connect to that server, and while there are many different technologies available, the one you'll need for Clarion work is the ODBC driver for MySQL, called MyODBC.

WARNING: Although I'll show you how to install the latest MyODBC driver, I did encounter a problem that forced me to downgrade to the 3.51 version. Hopefully SoftVelocity will fix the bug (PTSS 37155). If not, the information shown for the 5.x install is the same information you need for the earlier MyODBC installs.

First, download the MyODBC installer. You can find the 32 bit 5.1 installer [here](#).

As usual I've opted for the custom setup, although in this case it's not necessary at all.




Figure 25. Choosing the Custom setup type

The only two items being installed are the driver and the driver documentation. Note that I'm installing the 32 bit version of the driver. You don't want or need the 64 bit version for Clarion work, even if you're running on 64 bit Windows, because the bitness of the ODBC driver has to match the bitness of the application.




Figure 26. Setup components




Figure 27. Ready to install




Figure 28. Installing MyODBC




Figure 29. End of wizard

Setting up the data source

With both MySQL and MyODBC installed, and a database in place, the next step is to use the ODBC Data Source Administrator set up an ODBC data source so your Clarion application can talk to the database. (Although you can use a DSN-less connection with your Clarion application, that won't work when importing tables - you need a named ODBC data source.)

If you're on a 32 bit version of Windows, just locate the ODBC administrator via the Control Panel.

If you're on a 64 bit version of Windows, pay close attention! You will have both 32 bit and 64 bit versions of the ODBC administrator. You *must* use the 32 bit ODBC admin to create your data source or your Clarion application won't see it.

If you're not careful, Windows' naming convention for 32 bit and 64 bit systems will trip you up.

To set up data sources you need to use the version from the SysWOW64 directory. **WOW64** stands for Windows on Windows 64 bit.

The executable is here:

%WINDIR%\SysWOW64\odbcad32.exe

Do *not* use the 64 bit version, which oddly enough is located in the System32 directory (%WINDIR%\System32\odbcad32.exe).




Figure 30. The ODBC Administrator

Figure 30 shows the ODBC Data Source Administrator.




Figure 31. Choosing a driver

When you add a new data source you're presented with the driver selection window (Figure 31). Choose the MySQL ODBC 5.1 driver (keeping in mind that you may need to ultimately use a different version, depending on the status of PTSS 37155).

Next, fill out the data source name, the server address (localhost, if MySQL is installed on your development machine), the port (I'm showing the standard 3306, although in my own install I had to use 3307 because I already had an older version of MySQL running on port 3306), the user name and the password.

Once you have entered all of that information you can click on the Database droplist and the available databases will be displayed (assuming you have the server and the port entered correctly).




Figure 32. Setting connection properties

Just to be sure you have access, press the Test button.

Creating the data dictionary




Figure 34. Creating a new dictionary

Now you're ready to create the data dictionary. From within the Clarion IDE choose File | New | File. You'll see the New File dialog (Figure 34).

If you click on the Create button shown in Figure 34 nothing will happen. You won't get an error message or any other indication of a problem. What you must do is click on the Data Dictionary entry in the Quick Starts pane. *Then* you can click on Create.




Figure 35. Selecting the Quick Start

Clarion will create a new data dictionary. Save it as CModels.dct.

There are two ways to import tables into the dictionary. One is to use the Table Import capability, and the other is to use the Dictionary Synchronizer.

Table Import is the shortest and easiest way. Just click on the  icon on the DCT Explorer toolbar and choose Import Tables.

The Dictionary Synchronizer provides you with a more complete import/synchronization experience and a few extra options so I'll show that process, but the end result in this case is the same whether you use the synchronizer wizard or the table import wizard.




Figure 36. The Synchronizer menu option

As far as I know, the only way to call the Synchronizer is via the DCT Explorer's toolbar, as shown in Figure 36.

Start a new synchronization.




Figure 37. Starting the wizard

You want to synchronize with an ODBC data source. Leave the second field empty.




Figure 38. Synchronizing with ODBC

Set the Datasource field to the ClassicModels data source you previously created. You can leave all of the other fields blank, as the Synchronizer Wizard will pick up everything it needs via the ODBC data source.




Figure 39. Setting the data source

Your synchronization direction is from the database to the dictionary.




Figure 40. Setting the synchronization direction

You should see the tables listed on the left.




Figure 41. Available tables

Click on the >> button to move all of the files to the Synchronize list on the right.




Figure 42. Choosing the tables to synchronize

You don't need to worry about any of the Synchronizer options since this is a fairly small database.




Figure 43. Synchronization options




Figure 44. The Synchronizer

Figure 44 shows the Synchronizer. All you'll be doing at this stage is importing the entire database, but the Synchronizer is also capable of showing you differences between your database and your dictionary and giving you various ways of resolving those differences.

If you click OK at this stage you'll end up with an empty dictionary. You have to tell the Synchronizer which tables to add. You do that by right-clicking on a table and choosing Add To or by pressing Ctrl-A. You can also do this at the Files or Dictionary level if you want to add all the tables at once.




Figure 45. Adding the table to the dictionary

The + icons indicate the tables will be added to the dictionary. Click OK to proceed, then save the dictionary.




Figure 46. All tables marked for adding

Creating the application

To create the application go to File | New Solution, Project or Application. Select the Clarion for Windows category and the Application Quick Start.




Figure 47. Creating a new application

Select the Dictionary File and make sure the Application Wizard option is checked.




Figure 48. Setting the dictionary and enabling the Application Wizard

To get a basic app up and running just accept all the wizard defaults, and click Finish at the first opportunity.




Figure 49. The Application Wizard




Figure 50. Choosing the default layout




Figure 51. Generating browses and forms for all files




Figure 52. The generated procedures

Figure 52 shows the generated procedures.




Figure 53. The running application

And Figure 53 shows the running application. It may not be pretty yet, but it's a fully functional MySQL app!

Two problems with MyODBC 5.1




Figure 54. A bug in the ODBC driver

When I first ran my application against the CustomModels database I was surprised to see

only a single record displayed in the Customer browse. When I pressed PageDown, however, the browse loaded normally. Thinking there must be some ODBC setting out of whack, I went back to my ODBC administrator. But when I attempted to edit the CustomModels DSN the administrator gave me an Invalid attribute string error message (Figure 54).

It turns out that the Invalid attribute string error is due to a bug in the 5.1.7 MyODBC driver. The solution is to [download the patched driver](#) and copy the patched DLL overtop of the installed DLL (I found my installed version in C:\Program Files (x86)\MySQL\Connector ODBC 5.1).

After that I was able to edit the DSN, but the browse bug was still there and I couldn't find an obvious cause. I asked the Clarion Skype chat members if anyone had encountered this problem, and Roberto Renz advised me to use the MyODBC 3.51 driver instead of the 5.1 driver. I already had that version installed, so I renamed my original DSN, created a new MyODBC 3.51 DSN with the original name, and re-ran the app. Everything worked as expected.

A little while later Mark Riffey reported that 5.1.6 has been working well for him. I uninstalled 5.1.7, [installed 5.1.6](#), and my browses behaved normally again. I did a bit more digging and discovered a [reported bug in 5.1.7](#) that causes the driver to limit the result set to a single row. So the moral of this story seems to be to avoid 5.1.7.

Summary

To get a Clarion application working with MySQL you need three things: the MySQL server, the MyODBC driver, and a dictionary that corresponds to the database. In this article I've stepped through installing MySQL, installing MyODBC, and using the Dictionary Synchronizer to import the MySQL database.

Clarion.NET, Great Expectations, and the Emerald Isle

The [Denver DevCon](#) is fast approaching, and I've been preparing my presentation, titled "90 things you need to know about .NET, in 90 minutes or less!"

My presentation isn't about Clarion.NET (although it gets a few mentions), but about the wider world of .NET development. And it's a really wide world.

If programming languages were countries, Clarion (Win32) would be, oh, Ireland, let's say. Nice country, Ireland. Beautiful landscapes. Lots of history. Decent local economy (ignoring the moment the recent housing bust and related problems). You can have a good life in Ireland.

But let's say you've lived your whole life in Ireland, you've never watched much TV, you don't read a lot, and you're not really on the internet much. In other words, Ireland is your home and you don't know or care much about anywhere else. And then a rich aunt dies and leaves you a packet of money on the condition that you spend a year traveling the world, visiting at least one different country a week and spending at least one month on each of the seven continents.

Your head would be spinning at the end of that year. You'd have a whole different perspective on life, on the world, on little old Ireland.

That's kind of what it's like diving into .NET. It's not the *whole* programming world - Java's the other heavyweight out there right now, and there are lots of smaller countries (like Clarion) - but .NET takes up a sizable chunk of the available space. And as most travellers find when going to a foreign land, there are a whole lot of things in .NET that just don't make sense right away. Migrating from Clarion Win32 programming to .NET programming can be difficult.

But does it really have to be that way? Should we have to go somewhere else to do .NET? Isn't the whole point of Clarion.NET to let us stay in Ireland and reap the benefits of all the .NET goodness out there in the wide world?

In short, can't we just do business with .NET and not have to live in a full-on .NET country?

Two paths

There are a lot of potential paths to .NET for Clarion developers, and rather than sketch them all out (or as many as I can think of) I'll stick with two ends of the spectrum.

At one end is the idea that in .NET you leave the Clarion language unchanged and you use it to create .NET binaries instead of Win32 binaries. Theoretically this can be done - in fact, Andrew Barnham has more or less done it for Java with his [Clarion2Java](#) project, in which Clarion code, unchanged, is compiled to Java bytecode. If this same process could be done for .NET you'd still be living in familiar old Ireland, but you'd have the opportunity for a lot more foreign trade (i.e. interoperability with the rest of the .NET world). In reality, Clarion# isn't like this - some key aspects of the language have changed, and you do have to modify your code.

At the other end of the spectrum is the idea that Clarion.NET is a radically different experience from Clarion Win32. The language changes to be more .NET-friendly, the application architecture becomes more mainstream, etc. To continue the analogy, you leave behind the comforts of home and you travel the world - you get to know other cultures, other ways of doing things. You set aside your preconceived notions of what life (code) should be like, and you experience the richness of other cultures. Is Clarion.NET actually like this? Maybe. It all depends on the capabilities of the new AppGen and the templates that ship with it.

More likely the reality (once there's an AppGen) will fall somewhere in between these two extremes.

You're not in Ireland anymore

My impression is that many Clarion programmers would like to stay in Ireland. They like the promise of familiarity with extra functionality. They want an easy upgrade path to .NET.

Based on what we've seen so far in Clarion#, I'd say that the "stay completely in Ireland" option is out of the question. The Clarion# language is significantly different from the Clarion Win32 language in that both the WINDOW structure and the ACCEPT loop are gone. That completely changes how you write UI code in Clarion#. So you'll have to spend some time in the land of Windows Forms (WinForms), which for the sake of illustration I'll say is the United States. Now, if SoftVelocity changes to WPF (the newer replacement for WinForms) or Silverlight (a subset of WPF, for browser apps), you're off to somewhere else, like Japan.

The "stay at home" option didn't go away by accident. Some years ago SoftVelocity considered preserving the WINDOW structure (and perhaps even ACCEPT, though I'm not as sure about that), and decided against that approach. But even if they had retained those

language features the WINDOW structure would have to change to accommodate the unlimited variety of controls available in .NET. In any case SoftVelocity took another step toward the .NET mainstream.

There's still a very strong "local" flavor to Clarion.NET. The product has its own IDE. The Clarion# language, despite the loss of WINDOW and ACCEPT, is in most respects is very much like the Clarion language we already know. Much of the vocabulary of Clarion# is the same as the vocabulary of C# and VB.NET, the mainstream .NET languages; it's more like Clarion# is spoken with a thick Irish brogue.

Globalization is upon us

For good or for ill, globalization is a factor in software development just as it is for national economies. Clarion.NET is a response to those forces. Clarion developers want access to those other markets. But many seem to think they can have that without paying a price, without losing anything meaningful about the Ireland they love.

I don't think that's a reasonable expectation.

First, the Clarion/Ireland way of building applications is (with apologies to the very progressive Irish) a little out of date. Our apps use the GDI (part of the Windows API) to draw the user interface. That's not a terrible thing, but one of the touted benefits of going to .NET is the ability to spruce up the user interface. If you want to get the best UI out of .NET applications you use XAML, an XML-based declarative approach used in both Silverlight and WPF. WPF and Silverlight don't use the Windows API to draw the user interface, they use DirectX, a newer subsystem with support for both 2D and 3D rendering.




Figure 1. WPF application

Figures 1-3 show a few screens from Billy Hollis's now legendary [DNRTV webcast on building WPF line of business applications](#).




Figure 2. WPF application




Figure 3. WPF application

If SoftVelocity had ported Clarion to .NET unchanged, with WINDOW and ACCEPT intact, could you create those kinds of user interfaces? I think it's highly unlikely, and if you could do it, it would be a whole lot more work than doing it the "normal" way with XAML.

Will the new AppGen be able to work with XAML? Maybe, although the window designer's drag-and-drop-with-embeds approach we're familiar with is more applicable to a WinForms model.

Clarion's standard application architecture is also something of a problem. Newer application architectures emphasize something called Separation of Concerns (SoC). The idea is that

you want to divide the program up into parts that don't overlap in functionality. The user interface is one of those parts, the business layer is another, the database access yet another, etc. In a typical Clarion application the user interface code, the business logic and the database access are often lumped together in a single procedure. This makes it much more difficult to test and reuse code.

App migration possibilities

Let's stick a little longer with the hope of making a smooth transition from Clarion Win32 to .NET.

It's theoretically possible to take an existing Clarion application and port it to Clarion#. You don't have `WINDOW` and `ACCEPT`, but with some work you could probably reproduce most of the functionality using WinForms, which uses the same GDI technology to create windows as does Clarion Win32.

Some things are going to be problematic, such as buttons that are on tabs but located outside the tab's bounds. In Clarion Win32, those buttons show; in WinForms, they're outside the bounds of their containing control and don't show. (It's worth noting that you'd have the same problem if Clarion# had a `WINDOW` structure and translated that structure into a WinForms window behind the scenes.)

Let's say you overcome the UI issues. You'll also need to work through other language changes such as the loss of `OVER` and the move from one-based array indexes to zero-based array indexes. So you overcome those as well. In the end you'll have an app that looks pretty much like your Clarion Win32 app, and it'll have the same internal structure as your old app.

What exactly have you gained? Nothing much visually, although you can use a greater variety of custom controls more easily. How about the ability to call .NET code? Guess what - you can do that already from a Clarion Win32 app, though again not quite as easily as from a native .NET app.

The fact is many of the benefits developers expect to get from .NET just aren't available here in Ireland. They're out there in the rest of the world.

SoftVelocity's vision isn't fully a stay-at-home vision either. They're embracing a new data access technology (their LINQ to File provider) and they've said they will support WPF at some point. None of that stuff exists in the Clarion Win32 world.

Migrating to a new platform is seldom easy, and I think it's safe to say that the more advantage you want to take of .NET's capabilities, the more challenging that migration will be, and the more time you'll be spending in foreign lands.

And it's not just about you and your code; it's also about the code from all the third party vendors you may be using. How much of that code still applies in .NET? How much of that code can reasonably be ported to .NET?

The case for staying home

I'm a huge fan of .NET - I think it's going to be with us for a long time, and I'm excited about the many advances that have been made in programming tools and techniques on the .NET platform. I'm a big believer in the benefits of seeing the world. I write .NET code almost every day.

At the same time, I think we need to have an appreciation for what we have in our own country. No, Clarion Win32 isn't a perfect language, and the application architecture is a bit outdated. What we do have, however, is a very mature, very productive environment for building Windows applications. This environment, this culture, is the product of many years of work by a lot of talented individuals. It includes not just the Clarion code generation technology and the application architecture embodied in the templates, but also the many third party products and the collective knowledge about Clarion programming as found here in Clarion Magazine, in the SoftVelocity newsgroups, and elsewhere on the internet.

So enjoy your time in Win32 development; there will be value in Clarion 6/7+ for years to come. And if you're one of those Clarion developers planning to ride the Win32 product through to retirement, more power to you.

The case for going abroad

If you really do have a compelling need for a .NET solution, consider where you are on the above-mentioned spectrum. Are you still mostly trying to stay within the current Clarion way of doing things? If so, can you achieve most or all of what you want simply by [calling .NET code from Clarion](#) (or vice versa)? Perhaps you don't really need a full-on .NET solution just yet.

If you need something now, base your decisions on what's available now. If you can afford to wait, then wait. But in either case do your research; learn everything you can about how to build your kind of application in .NET. Do you need ASP.NET (WebForms), ASP.NET MVC, WinForms, WPF, Silverlight, Compact Framework, Windows Phone 7 (Silverlight), or any combination thereof? If you're planning a long-term strategy you should seriously consider the XAML-based technologies (WPF and Silverlight). And you should definitely be thinking of a more modern application architecture that embodies the principle of separation of concerns (a common feature of XAML-based applications).

If you'd like to fully adopt current best practices and mainstream technologies, and you absolutely must do it now, then you're going to be spending a good chunk of your time outside of Ireland. I'm talking Visual Studio and learning C# and/or VB.NET. Yes, you can build .NET applications with Clarion.NET even without the AppGen, but the toolset isn't nearly as rich. You may still want to use Clarion# to create libraries for tasks like TPS file access and reporting, but on the whole Visual Studio has a productivity advantage, assuming you're comfortable with C# or VB.NET syntax.

That productivity advantage may swing back to Clarion.NET at such time as there's an AppGen. But there's no way to know that until the AppGen is actually available. What if your need is for WPF and the AppGen generates only WinForms code? Or vice versa?

Be as prepared as you can be.

Conclusion

Don't just be prepared. Be realistic.

This transition, from Win32 to .NET, is oddly different from the last major transition, from DOS to Windows. We didn't have any tooling for Windows then - it was all new. So we had no particular expectations. This time around we all have years of Windows development experience. We have much more definite expectations, and in many cases those expectations aren't realistic.

In the mid-nineties, writing Windows applications typically meant enduring the pain of C or C++. Clarion for Windows provided a huge language productivity advantage *and* a huge code generation advantage. Good times.

The language *productivity* advantage really doesn't exist in .NET - [C# and VB.NET are pretty much equivalent to Clarion#](#) (and they come with a more feature-rich IDE). There may be some code *reuse* advantages: if you have a lot of non-UI code, or a bunch of reports, those may port fairly cleanly. And the Clarion# runtime lets you continue to do familiar kinds of file access.

The one big advantage most Clarion developers are waiting for is code generation. There too, some caution is in order. Many of us rely on a host of third party products, mature templates and a long-established runtime library. But the Win32 development culture we enjoy didn't appear overnight, and it's unreasonable to expect a .NET version of this culture to appear fully formed, like magic, on the day the AppGen ships. Cultures take time to develop. If SoftVelocity were to deliver the long-awaited Clarion.NET AppGen tomorrow, complete with templates, it would take time (probably years) for Clarion.NET environment (including the third party products) to reach the maturity of the Clarion Win32 environment.

It's going to take time to make the transition to .NET. It's going to take a lot of learning as well.

Clarion Win32 is a small, familiar country; .NET is hundreds of countries, some of them impossibly strange. But if you like to travel, this is a great time to see the world.

If you were to take those web pages and put them in book form they would fill a bookshelf. And if you took one of those books off the shelf and opened it, you'd find page after random page of articles. You'd have lots of cross references (see Volume 12, page 234) and a heck of an index (Google, Bing) but there would be nothing like a table of contents.

A table of contents is a wonderful thing. It provides you with an overview of the information; it helps you zero in on subjects of interest; it shows you things in context, so you can see how one piece of information relates to another piece of information; and it shows you things you may not have realized you needed to know.

Hi Dave. I think that the issue of programmer familiarity is only one aspect of this transition. Another is preservation of investment. If you have 1000 manhours invested into a Win32 App, ideally you would like to preserve as much of that investment into .NET as possible. Another is end-user comfort : which also fits into your familiarity perspective. End users resist changes to both the look and their workflow; even smallest changes cause people to fluster: and a complete stack replacement is always highly disruptive. The new environment may and should encourage switching to newer techniques in a graduated process and at least allow, upto as much as practical graduated, gentle transition for all stakeholders, programmers, end-users, support people etc. Evolution, not Revolution.

Different peoples needs and expectations and willingness to learn and experiment with new technologies; unproven within the context of their business needs; differ. Yet the above at least describes the Clarion.NET I would be willing to pay money for. Unless I have completely misread the situation I would think the product I just described would be attractive to most too; not just the tinkerers and the early adopters. If such a product existed 2 years ago, I would of brought it and learnt .NET.

Even a straight port will provide significant advantages as I have discovered with Clarion2Java. Managed code delivers productivity gains: runtime is more stable, easier to debug. And in clarion2java at least, compile duty cycle is significantly faster than Clarion Win32. Also gain access to new libraries (which you can do in Win32 anyway by bridging to .NET as you indicate above). SV doesn't have to solve everything in first release, just provide a solid foundation that is attractive to typical clarion programmer. Let the likes of yourself and Capesoft and other innovators work on enriching and extending the new foundation.

Some of the language problems you describe above are actually not terribly difficult to solve and solved in Clarion2Java without requiring clarion programmers to change their ways. OVER() attribute, Array Indexing and UI challenges such as controls appearing outside of their container bounds.

Thanks Andrew - you certainly have a better perspective than any of us I think, given your work with [Clarion2Java](#).

One thing to keep in mind is that SoftVelocity's perspective isn't necessarily yours or mine. They need sufficient sales to justify the investment in building Clarion.NET. Will they get that by creating a tool that's optimal for the existing (and, in global terms, quite small) user base? Or rather by creating a tool that has wider appeal but that has less appeal to that core user base? At the risk of sounding like a broken record, I don't envy

SV their choices.

Understood. Not having access to SV's books or business thinking, can only speculate. Yet I feel that my strategy quite likely aligns with their business strategy. So I will indulge in a little more speculation never-the-less :) ...

SV investment into Clarion.NET: spans multiple years. Manhour investment must be at least 5k hours if not more. c2j is approx 800 hours. 3 years people have been complaining about a lack of an AppGen. c2j has an app gen! : Clarion's. I do about 70/30 clarion & java in terms of time; because the appgen is a proven effective tool; even in c2j context.

I don't envy their position. Selling programming tools to programmers these days is hard work; most language innovation that professional industry pays attention to occurs in OSS environments or by the giants like Microsoft. None spends money on unproven solutions anymore: it has to be either free or underwritten by a giant (Microsoft). If SV was a modern startup with no customer base and no software asset and just a nebulous plan to RADify .NET and charge money for it, I think pretty much anyone would consider what they are trying to do to be highly unlikely to succeed. But when you think about it, this is pretty much what SV have done: they have barely leveraged their existing assets/customers.

Look at how successful Android is, it is successful because it faithfully replicates the Java language even though strictly speaking it isn't Java. SV have pegged the ground with something no-one recognizes; that has no mind-share at all.

Yet if my speculations are broadly correct then they have choices; they have a existing customer base and a software asset. A big difficulty from my point of view is that they now have multiple largely incompatible product streams to support: Clarion and Clarion.NET. But it wouldn't be too difficult, I should imagine to consolidate their disparate streams into a unified strategy along the lines I suggest above.

If their current internal strategy is, "how can we repackage the .NET world, add value and resell it", I would assert that this is a flawed strategy. A better strategy would be "What is the best way to bring .NET to our customers and allow our existing assets embrace and extend .NET".

Thanks Dave (and Andrew), stimulating as usual.

Let's not forget that many Clarion 'programmers' are not, strictly speaking, programmers but more like Business Analysts. Our job is to automate our customers' business processes and ensure that their business rules are applied throughout their organisation.

(‘Programmers’ on the other hand, get their kicks from cutting code. New toys are of more interest to them than a productive end result.)*

The seductive UI that .Net can deliver is of little interest to my customers; on the other hand bang for the buck is much more important. And there is no doubt that Clarion delivers that in spades.

Much to the chagrin of mates who are .Net aficionados, I have yet to knock back a customer request because it cannot be delivered - and quickly - in Clarion. We have thin clients, web services, interaction with all sorts of documents.

My personal take on .Net is that it's the product of a bunch of cosseted geeks happily playing in an enormous sandpit up in Redmond. Those guys may have intellectual and marketing firepower but they're not street smart. Bruce Barrington was when he dreamed up CPD.

Looking forward I only see one hole in the business development spectrum that the current Clarion/third party toolset does not plug, and it's sneaking up fast. That hole is mobile devices. The recent release of tablets in the 5" to 9" screen range has suddenly provided a device that could shoulder the PC aside - as, it turns out, has already happened in Japan. Once you have pervasive and inexpensive mobile broadband and a pocketable device with reasonable battery life and a useable interface you can un-tether people from their desks and all sorts of interesting things become possible.

There are already toolsets to address this market but they appear to be universally clueless about data. So if I was SV I'd sidestep .Net altogether and build something that could produce data-rich mobile applications. (We tend to forget that 'data-rich' is Clarion's strong point.)

C7 Tips: Text Search And Regular Expressions

Work in C7 for a while, and you sometimes forget how much more primitive some things are in C6 and earlier versions. Search and replace is one such example.

I recently needed to compare SQL schemas from two PostgreSQL databases. I have two web sites (ClarionMag and DevRoadmaps) that share a core code base; they also share a database design, or schema. I also have development versions of both of these sites, so that means I have potentially four different databases to keep in alignment.

I don't usually work on ClarionMag and DevRoadmaps at the same time; instead, I'll make a change to one of my development databases, and then I'll propagate that change to the two live databases and then at some point make copies of the live databases for further development work.




Figure 1. Comparing two raw schema dumps

I use a fairly simple process to keep my database schemas synchronized. I dump each database schema to a text file, and then I use a difference program like WinDiff to compare the files. But the raw schema files don't lend themselves to this approach because of different unique identifiers. Figure 1 shows a portion of a compare between two schema dumps.

The mostly black bar down the left side is an indicator of where in the files those differences occur (compare with Figure 7 below). There are about 1500 differences between the two files, and almost all of them are due to lines that begin with -- TOC entry or -- Dependencies. I need to clear out those lines in order to see the meaningful differences between the two schemas.

In this article I'll show you how to do that with regular expressions. But first a quick review of the differences between C6 and C7 searching functionality.

C6 search vs C7 search




Figure 2. C6 search and replace options

Figure 2 shows the C6 search and replace window.

The only search options are to match on whole words and match case. Search is available in the text editor, for the current file (or procedure, structure, or embed).




Figure 3. C7 search and replace options

C7 adds a number of new options to search and replace, as shown in Figure 3.




Figure 4. "Look in" options

There are a number of important improvements in C7's search and replace. Both the find and replace fields have history droplists, so you can pick from previously-entered values. C6 lets you search the currently context only, while the C7 "Look in" droplist contains additional choices (Figure 4).

Keep these options in mind when you're searching. It's easy to fall into C6 habits and only think about searching the text in front of you. But with C7 you can also search selected text, the currently open documents, or all documents in the project or solution. You can also search folders: click on the [...] button after the droplist to choose a specific directory to search.

All of these are terrific features that can save you a ton of time. But this article is about yet another search feature: regular expressions.

Search types




Figure 5. The search type droplist.

C7 provides three types of searches: standard, wildcard, and regular expression. Figure 5 shows the search type (Use) droplist.

Standard searches are what we have in C6. Your only search options are whether the search is case sensitive and whether it looks at whole words only.

Wildcard searches let you substitute * and ? in exactly the same way you use them in directory lists. A * stands for more than one character (any character), and ? stands for any single character.

The important thing to remember about wildcard searches is that they are only meaningful inside other text. In my example, if I my search term is

```
-- Dependenci es
```

and my text is

```
-- Dependenci es: 823 7
```

C7 will match only up to the end of Dependenci es - it will not include the : or any other of the following characters. (Visual Studio, on the other hand, will match wildcards before and after a search term, to the beginning/end of the line.)

If my search term is

```
-- Dependenci es*7
```

then C7 will match the whole line, but that will work only as long as my last character is 7. I really want to be able to match all lines that begin with -- Dependencies and replace them with a blank string.

Enter regular expressions.

Searching with regular expressions

If you're not familiar with regular expressions (regex), take a moment to read [Carl Barnes' excellent article](#) on the subject. In short, regex is pattern matching. And since C7 supports regex searches, all I need to do is find the right pattern and I'll be able to replace the lines that begin with -- TOC entry and --Dependenci es with empty strings so WinDiff can show me just the differences I care about.

In this case the expression is pretty simple: I just follow my previous search terms with a period and an asterisk (.*). That's regex for any character repeated any number of times.




Figure 6. Using a regex

You can match the beginning and end of a line with the ^ and \$ characters, but these don't seem to work in C7. But in this case they're not needed.




Figure 7. Comparing the adjusted schema dumps

After searching for and replacing -- TOC.* (and doing a couple of non-regex searches specific to my schemas) WinDiff now shows me just the relevant differences between the schemas (Figure 7).

Regex search and replace made it easy to remove all of the "noise" from the schema dumps and focus in on the important differences.

C7 ships with a regex toolkit - it's on the Tools menu.




Figure 8. The Regular Expressions Toolkit

You can use the regex toolkit to build and test your expressions. In Figure 8 I've typed in my expression and have pasted some sample text into the Input box. When I press OK any matches are highlighted, so I can verify that my regex is working as expected. The toolkit will also create a .NET assembly with a compiled version of your regex, although that's only applicable for .NET development, not C7 work.

Summary

Clarion 7's search and replace features go well beyond those found in C6. In combination with multi-file, project-wide and directory-specific search, regular expressions are a powerful tool for finding and replacing text. I've used only the simplest of expressions here; many more complex expressions are possible. See [Carl's article](#) for more information.

These don't seem to work as expected (but do in notepad++): search: (newtable)\s([\^s]+)\$ replace: CREATE TABLE \2 (id serial, remarks text);

--something like the following: newtable fred --becomes: CREATE TABLE fred (id serial, remarks text);

I can't find the right documentation to explain how to do this, and using patterns like \1 or \$1 haven't yielded the desired results.

Bob Zaunere's Keynote

The ClarionLive DevCon got off to an official start this morning with a welcome from and announcements by Arnold Young and John Hickey. This is the first time I've attended a conference that was simulcast to web attendees, and despite Arnold and John's herculean efforts there were a few glitches. First a router failed; Benjamin Krajmalnik rode to the rescue with a replacement. Connectivity issues with Florida prevented SoftVelocity president Bob Zaunere from presenting his webcast at the appointed time, so Bob Foreman stepped in and delivered the first half of his presentation while the team sorted out the technical issues. I'm afraid I don't have a lot to say about that first half as I was busy assisting with testing connections.

SoftVelocity president Bob Zaunere began his keynote by thanking John and Arnold for their efforts, and commenting on the passion Clarion developers have for the product. This year marks SoftVelocity's tenth anniversary and Bob Z reviewed the many Clarion product releases in that decade, a more substantial list than most of us probably realize.

He reminded us of David Bayliss's comment to the effect that ABC was "the big bang", and by extension Z dubbed C7 the supernova (at the end of the C6 lifetime). C7 supports 15 years of legacy Clarion versions, and is one IDE for both Windows and .NET.

Z announced two new releases: Clarion 7.3 and a pre-release of C8. The updated IDE features cleaner icons, locators at the top of every list, more keyboard shortcuts and both simple and complex views of data.

Z briefly showed AppGen.Net, which stores apps in Appx files, signifying an XML app format. He stated that code generation is working well, but the UI is still under construction. This was a very quick look - no generated code or running application was shown.




Figure 1. AppGen.NET

AppGen.NET includes designers, extensions and embeds.

Clarion# makes it easier to call .NET code from a Clarion Win32 app. Just add NAME and PUBLIC attributes to a .NET procedure and you can call that procedure from Win32 as easily as you call any other DLL procedure. There is no need to use COM or a C++ wrapper.

Z closed by declaring Clarion has “a long history, and a bright future”
